

EASAV Membership Updates

EASAV now has two membership categories: Voting and Associate Memberships!

Voting Memberships (Fee: \$130/year):

- For veterinarians who are registered with the AbVMA
 - (As per the EASAV Articles of Association, AbVMA registered vets *do not qualify* for associate membership)
- Newly AbVMA-registered vets receive a complimentary membership for the remainder of the year in which they registered

Associate Memberships (Fee: \$75/year)

- For veterinarians who are *not registered* with the AbVMA
 - I.e.: out-of-province, on maternity leave, foreign-trained
- For AHTs (RVTs are also AHTs)

Who should consider getting a membership with EASAV?

- Veterinarians & AHTs who want to:
 - Access in-person and video seminars at member rates
 - Evening in-person and recorded seminars: Free
 - Full day seminars: \$105
 - Enjoy free attendance for their families to social events (summer/fall BBQs, dinner with speakers)
 - Have priority seating to events with limited numbers
 - Volunteer on committees or with special projects

Want to edit or add your clinic to our website clinic directory?

- One of your practice owners must be a voting member of EASAV to add your clinic to our directory!
- Our directory includes:
 - Your clinic location on our google map
 - A search engine which can help the public locate clinics by service provided (I.e. exotics, urban hen management)

 - Click on Find Clinic on the black bar at the top of the website! (www.easav.ca)

Do I need to be a member to manage my online CE registrations?

- **NO!** You do not need to be a member to use our website and receive email notifications
- **You need a profile on our website to:**
 - Register yourself and/or your staff for our CE and social events
 - Pay for multiple staff members to attend our CE (members or not)
- **Please note:** All those you register for CE must also have a user profile on our website
